ELECTRICITY REGULATION ACT, 2006

**DETERMINATION REGARDING THE INTEGRATED RESOURCE PLAN AND
NEW GENERATION CAPACITY**

I, Dipuo Peters, Minister of Energy hereby approve the attached Integrated Resource Plan (IRP1 in **Schedule A**) for implementation as per the requirement of the electricity regulations on new generation capacity (Regulation No. 9116, dated 05 August 2009). The attached IRP also takes into account energy efficiency and demand side management projects.

In line with the IRP, I hereby determine that new generation capacity is required in accordance with Section 34 of the Electricity Regulation Act (Act No. 4 of 2006). The required new generation capacity must be met through the projects listed in the IRP. In respect of energy efficiency, demand side management and renewable energy, **Schedule B** outlines the framework for implementation of such projects.

Schedule A

Integrated Resource Plan (IRP 1)

The IRP 1 gives effect to the following policy objectives:

- (i) 10 000 Gwh (approximately 4% of the energy mix) of renewable energy by 2013;
- (ii) The implementation of Energy Efficiency and Demand Side Management through a financial incentive scheme (the standard offer); and
- (iii) Installation of one million solar water heaters.

In respect of (i), this will be met by licensing the projects in IRP 1 below under the "MTPP", "REFIT" and "Sere and CSP" programmes.

In respect of (ii) and (iii), this will be met through the standard offer programme ("Demand Side Management programmes" in IRP 1) in accordance with the implementation rules developed by the National Energy Regulator of South Africa.

In addition, projects in IRP 1 below ("Current Programmes") that predate the electricity regulations on new generation capacity may be licensed.

Projects listed in IRP 1 must comply with the codes and rules prescribed by the National Energy Regulator of South Africa.

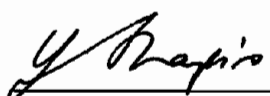

I, Sibusiso Joel Ndebele, Minister of Transport, hereby, in terms of sections 30(3) of the National Ports Act, 2005 (Act No. 12 of 2005), concur with the amendments to the Port Directives developed by the Ports Regulator relating to the proper performance of the functions of the Ports Regulator.

The Port Directives are amended as follows:

1. The current sub- directives 22(13) and 22 (14) are hereby deleted from the Port Directives.
2. Sub-directives 22(15) and 16 shall become new sub- directives 22 (13) and 14 respectively.
3. Sub- directive 23(2) is hereby amended by deleting the words "will give due consideration to whether it is desirable that the tariffs which it finally approves" and substituting in their place the word "must". The opening phrase of sub-directive 23 (2) is therefore amended to read as follows:

"In considering the Authority's proposed tariffs, and any subsequent proposed significant variations, the Regulator must enable the Authority to-..."

**REQUEST FOR THE CONTINUATION OF STATUTORY MEASURES RELATED TO
REGISTRATION AND PROVISION OF RECORDS AND RETURNS FOR COTTON, IN TERMS
OF THE MARKETING OF AGRICULTURAL PRODUCTS ACT, 1996 (ACT NO 47 OF 1996), AS
AMENDED**

1. STATUTORY MEASURES – REGISTRATION, RECORDS AND RETURNS

The request received from Cotton South Africa, is that the Minister of Agriculture, Forestry and Fisheries, in terms of section 10 of the Act, by notice in the Government Gazette, direct that the statutory measures, namely registration of certain role-players and the keeping of records and the submission or returns to Cotton South Africa, be continued for another four years to lapse on 31 March 2014.

2. INFORMATION REQUIRED BY SECTION 10 OF THE ACT

The particulars as required by section 10 of the Act to be included in a request for the continuation of statutory measures, are as follows:

- 2.1 The statutory measures that are requested to be continued, would relate to cotton.
- 2.2 The categories of directly affected groups which would probably be affected by the proposed continuation of the statutory measures, are:

Registration:

Persons who produce seed cotton, persons who purchase seed cotton from producers and who purchase cotton lint from producers or ginnerers, processors of seed cotton and importers and exporters of cotton.

Records and returns:

Persons who purchase seed cotton from producers and who purchase lint from producers or ginnerers, processors of seed cotton and importers and exporters of cotton.

- 2.3 Letters of support for the proposed continuation of the statutory measures on cotton were received from the following institutions:
- SA Cotton Producers' Organisation (SACPO);
 - SA Cotton Ginnerers' Association (SACGA);
 - SA Cotton Textile Manufacturers' Association (SACTMA);
 - SA National Consumer Union (SANCU); and
 - SA Clothing and Textile Workers Union (SACTWU).
- 2.4 The statutory measures will apply to the whole of the Republic of South Africa.
- 2.5 According to the applicant, the proposed continuation of the statutory measures will further the objectives of the Act as stipulated in section 2(2) thereof.
- 2.6 The manner in which the objectives referred to in section 2(2) of the Act will be furthered (namely the increasing of market access for all market participants, the promotion of the efficiency of the marketing of agricultural products, the optimisation of export earnings from

agricultural products and the enhancement of the viability of the agricultural sector), are summarised below:

"Since deregulation of the agricultural industry, great value is being placed on product market information, which is no longer as readily available and accessible as before. In this environment, Cotton South Africa has since 1998 established itself as the major local source of cotton market information, in that many role-players in the cotton industry have become dependent on the information services provided by Cotton South Africa, which is regarded as critical for strategic planning by the industry.

Unbiased and reliable market information, which is available on a continuous and timeous manner, will not only increase market access for all market participants, but will also promote the efficiency of the marketing of cotton and enhance the viability of the cotton industry and the agricultural sector at large. Market information will furthermore lead to the optimisation of export earnings without being detrimental to the number of employment opportunities or fair labour practice.

The market information obtained up to now by way of these statutory measures has also proved to be invaluable to Cotton South Africa in its capacity as industry forum, as well as in the advancement of its main objectives such as the stimulation of the production and the usage of cotton; the enhancement of the marketability of cotton through research; the establishment of quality standards and norms, and the facilitation of the development of the emerging cotton production sector.

Since deregulation, relevant market information obtained by way of statutory measures and other means has been disseminated among others, in the following manner:

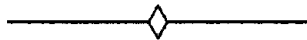
- By way of monthly market reports on both the local as well as the international situation, posted and/or e-mailed monthly to core producers and other role-players in the industry as well as to the media.
- By way of Cotton South Africa's website which records on average 41 000 visits annually.
- By convening farmer information days where relevant and useful information is communicated to farmers.
- By way of publications such as the quarterly Cotton South Africa magazine, which provides, amongst others, feedback on research projects and small scale farmers activities. The magazine is currently mailed to about 1 920 farmers, which include about 450 small scale farmers, as well as to more than 500 other subscribers.
- By way of other means such as articles in various agricultural magazines.
- A comprehensive Management Guide for Commercial Farmers as well as a Cotton Guide for Small Scale Farmers are also made available by Cotton South Africa to current and potential cotton farmers.
- From time to time, Cotton South Africa also takes part in shows, exhibitions and expo's where market information is disseminated.
- By way of personal contact, *ad hoc* requests and international surveys.
- Information on various cotton matters are also being made available by way of the following publications which are obtainable from Cotton SA:
 - Core Cotton Statistics Booklet
 - Educational brochures (for schoolchildren and students)
 - Organisation Information Brochures
 - Small Farmer Weed Identification Guide
 - Scouting guide for Cotton Pests

- Cleaner Cotton Production Guide
- Integrated Pest Management CD
- Organic Cotton CD
- Video on Cotton Picking Techniques

In conclusion, in the yarn manufacturing industry, increased processing speeds, new spinning technologies and heightened quality expectations, have changed the industry's focus and buying strategy of raw materials, hence the fact that up to date crop information is now more critical than ever before. Fibre utilisation decisions taken by the ginning and spinning industries, therefore have a more direct impact on the primary cotton producing industry, be it emerging or commercial farmers. These farmers are totally dependent on proper and accurate market information to assist them to conform to the strict requirements set by the spinning industry with regard to their raw material inputs.

The statutory measures will not be detrimental to the number of employment opportunities within the economy or to fair labour practise."

- 2.7 The current statutory measures that are to be continued, as published in Government Gazette No. R.1039 and R. 908 of 15 September 2006, will lapse on 31 March 2010.
- 2.8 The *status quo* will be maintained in respect of the body that is responsible for the administration of the statutory measures and mentioned in the regulations, namely Cotton SA (a non profit seeking company under section 21 of the Companies Act, 1973 (Act No 61 of 1973)).

**APPLICATION FOR AN AMENDMENT OF STATUTORY MEASURE (LEVY) ON COTTON IN
TERMS OF THE MARKETING OF AGRICULTURAL PRODUCTS ACT, 1996 (ACT NO 47 OF
1996), AS AMENDED**

1. AMENDMENT OF STATUTORY MEASURE – LEVIES

Cotton SA requested Ministerial approval for the amendment to the statutory levy on cotton lint. The request is that the Minister, in terms of section 15 of the Act, by notice in the *Government Gazette*, direct that the levy amounting to 20 cents per kg locally produced cotton lint (excluding VAT), also be made applicable on all cotton lint imported into South Africa for further processing, and be made payable by the importers to Cotton SA.

2. INFORMATION REQUIRED BY SECTION 10 OF THE ACT

The particulars as required by section 10 of the Act to be included in a request for the amendment to a statutory measure, are as follows:

- 2.1 The amendment to the statutory measure, would relate to cotton lint (cotton lint is the fibre derived from seed cotton after the seed cotton has been ginned, i.e. after the cotton seed has been separated from the fibre).
- 2.2 The categories of directly affected groups which would probably be effected by the establishment of the proposed statutory measure, are those groups of persons who are party to the purchase of seed cotton from producers, those persons who process seed cotton for the sale of the products derived therefrom, persons who purchase cotton lint from producers or ginners, persons who import or export seed cotton or products derived therefrom, persons who import cotton lint and those persons who produce seed cotton.
- 2.3 Letters of support for the proposed statutory measure on cotton, by the different categories of directly affected and other groups in the cotton industry, were received.
- 2.4 The proposed statutory measure will apply to the whole of the Republic of South Africa, in order to have a uniform levy.
- 2.5 According to Cotton SA, the amendment to the statutory measure applied for, will further the objectives of the Act as stipulated in section 2(2) thereof.
- 2.6 The manner in which the objectives referred to in section 2(2) of the Act will be furthered (namely the increasing of market access for all market participants, the promotion of the efficiency of the marketing of agricultural products, the optimisation of export earnings from agricultural products and the enhancement of the viability of the agricultural sector), are summarised in the following motivation by the applicant:

“The principle that a commodity should take responsibility for the financing of its industry functions is generally accepted but in the case of cotton, only a certain sector currently bears this responsibility, namely the cotton farmers. Although the current levy is payable by ginners on cotton lint produced, this levy is indirectly recovered from cotton farmers in that ginners take the levy into account in their pricing structures.

In order to create a more equitable situation where all role players in the cotton chain contribute to the services provided by Cotton SA from levy income, a broader base for the collection of the levy would be more just, as all role players equally enjoy the benefits ensuing from the application of levy income. The easiest and most simplistic way to

achieve this would be to make the levy applicable on all cotton imported from local processing as this cotton is also indirectly benefiting from industry-wide functions paid for by local cotton produced by local farmers. The implementation of a levy on imports will spread the cost of industry programs across a broader base.

South African farmers have been the only sector paying (by means of levies) for information, research and promotion programs designed to lower production and processing costs on the one hand and to boost consumer demand for cotton products on the other hand, for more than 30 years. Local cotton producers are concerned about the fact that growers outside the RSA (mainly from SADC countries) whose cotton is purchased by local spinners (duty free) are indirectly benefiting from the industry wide functions as well as market development paid for by local producers, while these foreign growers have never been requested to assist in paying for these privileges. The philosophy behind an import levy is simply that as all imported cotton benefits from local initiatives it should also pay for its share of the cost.

The major part of the local cotton demand is annually imported. On average over the past 10 years, only 37% of cotton carried the levy burden to pay for all industry functions provided by Cotton SA.

There are five RSA gins that are presently subject to the payment of statutory levies on cotton lint produced. Should imported cotton lint also be subject to levies, only five RSA spinners who import cotton for further processing will be affected.

Should the 20c/kg levy be collected on cotton lint imports, the total levy value is expected to be relatively small in proportion to the value of the imported cotton lint itself. The total value of RSA cotton lint imports for the past season (2008/09) is estimated at about R450 million (calculated at the average price for which cotton lint was sold by local ginners in 2008/09) with a total potential levy value on these lint imports of about R7,3 million, which represents only 1.6% of the total imported value. In all likelihood, there will be no measurable change in prices paid by RSA consumers for cotton products because of the introduction of a levy on imported cotton, as for instance, the cotton value in a cotton shirt accounts for only about 3% of the retail price of the shirt.

The proposed levy on imported cotton may encourage spinners to rather take up more local cotton instead of importing, as spinners who satisfy all their needs from local cotton, will not be liable to pay any levies.

The levying of cotton imports as proposed, will for the reasons stated above, not only increase market access for all market participants, but will also promote the efficiency of the marketing of cotton and enhance the viability of the cotton industry in particular, and the agricultural sector at large. "

2.7 DATE OF IMPLEMENTATION AND DURATION OF STATUTORY MEASURE:

The amendment to the measure requested for should be implemented before the forthcoming marketing season which starts on 1 April 2010 and it was suggested that the duration of the proposed amendment would be until 31 March 2012 when the current levy will lapse.

2.8 MOST APPROPRIATE BODY TO ADMINISTER MEASURE:

Cotton SA, a non profit seeking company under section 21 of the Company Act, is the most appropriate institution for the implementation and administration of the statutory measure applied for. This company which is industry driven and independent has proved itself over the past 12 years to be a capable, unbiased and responsible administrator of the current statutory levy.

The Board of Directors consist of:

- four persons representing producers of which one is a representative of small scale farmers;
- two persons representing the cotton ginning industry;
- one person representing the cotton spinning industry;
- one person representing the clothing and household textile sector;
- one person representing a national consumers organisation; and
- one person representing the labour sector.

2.9 PARTICULARS ON ENFORCEMENT

As Cotton SA was formed *inter alia* for the administering of the proposed statutory measure relating to levies, the most appropriate means of organising the inspection and the enforcement of the intervention would be to assign that function to the company. In this regard it is envisaged that the Minister would appoint either personnel of the company or independent contractors as inspectors in terms of section 21 of the Act to inspect and enforce the proposed measure.

The persons liable to pay levies under the measure are all registered with Cotton SA and required to submit monthly returns to Cotton SA. The company will be aware of failure to comply with the measure. Furthermore, the company can carry out random inspections from time to time, to ensure the compliance with the measure.

2.10 FINANCIAL IMPLICATIONS FOR THE FISCUS

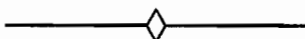
The levy will be collected from ginner and spinners and be used to finance the functions of Cotton SA. The financial implications for the fiscus would be all costs incurred in investigating and promulgating the amendment to the current statutory levy.

2.11 DISPOSAL OF FUNDS AND ASSETS IN CASE OF DISSOLUTION

In the event of Cotton SA being deregistered or terminated, all statutory funds and assets of the company acquired with statutory funds, after meeting all its obligations and paying all its debts, should be transferred to another South African organisation with similar objectives, subject to the approval of the Minister of Agriculture, Forestry and Fisheries.

2.12 AUDITING MEASURES

The accounts of Cotton SA will be kept in accordance with generally accepted accounting practises and be subject to annual audits by the Auditor-General.

REQUEST FOR THE CONTINUATION OF STATUTORY MEASURES IN THE LUCERNE INDUSTRY

1. STATUTORY MEASURES -REGISTRATION AND RECORDS & RETURNS

The statutory measures that are requested to be continued for a further period of 3 years, are –

- The keeping of records and the submission of returns to the National Lucerne Trust (NLT) by dealers and processors of lucerne seed and hay, in terms of section 18 of the Marketing of Agricultural Products Act; and
- the registration of producers, processors and dealers of lucerne seed and hay, in terms of section 19 of the Marketing of Agricultural Products Act.

2. INFORMATION REQUIRED BY SECTION 10 OF THE ACT

The particulars as required by section 10 of the Act to be included in a request for the continuation of a statutory measure, are as follows:

- 2.1 The statutory measures that are requested, would relate to lucerne seed and lucerne hay.
- 2.2 Producers, traders and processors of lucerne seed and lucerne hay will be directly affected by the measures.
- 2.3 The level of support for the proposed continuation of the statutory measures on Lucerne seed and hay is being tested and comments are being requested from directly affected groups.
- 2.4 The proposed statutory measures will apply to the whole of the Republic of South Africa.
- 2.5 According to the applicant, the continuation of the statutory measures applied for, will further the objectives of the Act as stipulated in section 2(2) thereof. Such establishment will also not contravene section 2(3) of the Act.
- 2.6 The manner in which the objectives referred to in section 2(2) of the Act will be furthered by the proposed statutory measures (namely the increasing of market access for all market participants, the promotion of the efficiency of the marketing of agricultural products, the optimisation of export earnings from agricultural products and the enhancement of the viability of the agricultural sector), are summarised below:

“The NLT has for many years acted as the mouthpiece of the lucerne seed industry. In 2001 the NLT received a mandate from lucerne hay role players to also act as mouthpiece and secretariat for the lucerne hay industry. As no reliable industry information was available, the NLT applied for two statutory measures, namely registration and records & returns. This was granted by the Minister on 20 April 2007.

Since 2004, 266 lucerne hay producers and 47 lucerne hay dealers/processors were registered. Amongst these there are 19 black and 50 colored emerging farmers.

To date the lucerne industry has not relied on statutory levies to finance certain functions in the industry. Nevertheless the NLT in co-operation with the University of the Free State for

the first time put in place an official quality control and grading system for lucerne hay that was implemented on 1 October 2006. This will ensure a uniform grading system for the whole of South Africa, and will contribute greatly towards ensuring a level playing field for all participants in the lucerne hay industry. At this stage participation in the grading system is voluntary but should the need arise the industry may request statutory authority to fund and ensure compliance thereto.

To make the lucerne industry accessible to existing and upcoming farmers it is necessary to continue to register producers, dealers and processors in order to have a database of who is involved in the industry and to collect and disseminate information. Lucerne plays a crucial role as feedstock and few people realize that in terms of area planted it is one of the largest crops in the country. It is also one of the crops ideally suited for the smaller or emerging farmer to produce."

2.7 DATE OF IMPLEMENTATION AND DURATION OF STATUTORY MEASURE:

The current measures lapse on 30 April 2010. The continuation is requested for another 3 years.

It should be borne in mind that the measures will, in terms of the Act, be subject to evaluation and review by the National Agricultural Marketing Council at least every two years. Furthermore, the Act provides for the application to be made for the repeal of statutory measures.

2.8 MOST APPROPRIATE BODY TO ADMINISTER THE MEASURES:

The NLT will administer the measures. The NLT is a discretionary Trust and has the required capacity in terms of personnel, infrastructure and skills to administer the measures in an unbiased and responsible manner. The Board of Trustees of the NLT consists of:

- One trustee representing the Minister of Agriculture
- One trustee representing the Lucerne seed producers
- One trustee representing the Lucerne seed trade
- One trustee representing the Lucerne seed cleaners
- One trustee representing the Lucerne hay producers
- One trustee representing the Lucerne hay dealers/ processors
- One trustee representing the Small scale farmers

2.9 PARTICULARS ON ENFORCEMENT

The inspection and enforcement of the measures will be the responsibility of the NLT and will be carried out by inspection personnel already appointed by the Minister in terms of section 21 of the Marketing of Agricultural Products Act.

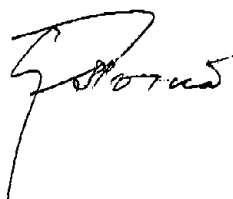

SCHEDULE

1. In this Schedule any word or expression to which a meaning has been assigned in the Marine Living Resources Act, 1998 (Act No. 18 of 1998) and the Regulations in terms thereof published in Gazette No. 19205 in Notice No. R1111 of 2 September 1998, shall bear the meaning so assigned to it and, unless the context otherwise indicates—

"abalone" means any shellfish of the species *Haliotis midae*, also known as "perlemoen";

"albacore" means the species *Athunnus allalunga*;

"anchovy" means any fish of the species *Engraulis encrasicolus* (previously known as *Engraulis capensis*);

"big eye tuna" means the species *Thunnus obesus*;

"east coast crustacean" means any crustacean, including shrimps, prawns and langoustines found in the waters of the Province of KwaZulu-Natal and caught by means of bottom trawl nets;

"east coast sole" means any fish of the species *Austroglossus pectoralis*;

"gutted" means cleaned by removing the viscera, but not the removing the head or the gills;

"gutted and gilled" means cleaned by removing the viscera and the gills, but not removing the head;

"hake" means any fish of the genus *Merluccius*;

"headed & gutted" means cleaned by removing the head, gills and viscera;

"horse-mackerel" means any fish of the species *Trachurus trachurus capensis*;

"kingklip" means any fish of the species *Genypterus capensis*;

"langoustine" means any crustacean of the species *Metanephrops mozambicus* (previously known as *Metanephrops anadamanicus*);

"monkfish" means any fish of the species *Lophius vomerinus*;

"patagonian toothfish" means any fish of the species *Dissostichus spp*;

"pilchard" means any fish of the species *Sardinops sagax* (previously known as *Sardinops ocelatus*);

"redeye or round herring" means any fish of the species *Etrumeus whiteheadi*;

"red spotted sole" or "red spotted tonguefish" or "sandrat" means any fish of the species *Cynoglossus zanzibarensis*;

"ribbonfish" means any fish of the species *Lepidopus caudatus*;

"seaweed" means any marine macro-algae, including Kelp [*Ecklonia maxima* and *Laminaria pallida* (including *Laminaria schinzii*)] and other species such as *Gracilaria gracilis*, *Gracilariopsis spp* and *Gelidium spp*;

"shark" means any fish of the class *Chondrichthyes*.

"shrimp" means any crustacean of the superfamilies Caridea and Penaeoidea including the genera *Callinassa* and *Upogebia*;

"snoek" means any fish of the species *Thyrsites atun*;

"south coast rock lobster" means any rock lobster of the species *Palinurus gilchristi*;

"southern bluefin tuna" means the species *Thunnus maccoyii*;

"squid" means any squid (chokka) of the species *Loligo vulgaris reynaudii*;

"swordfish" means the species *Xiphias Gladius*;

"the Act" means the Sea Fishery Act, 1988 (Act No. 12 of 1988);

"tuna" means any fish of the species *Allothunnus fallai*, *Euthynnus affinis*, *Gymnosarda unicolor*, *Katsuwonus pelamis*, *Sarda orientalis* or *Sarda sarda* or any species of the genus *Thunnus*

"west coast rock lobster" means any Cape or spiny rock lobster of the species *Jasus lalandii*;

"west coast sole" means any fish of the species *Austroglossus microlepis*.

"yellow tuna" means the species *Thunnus albacares*;

2. Subject to paragraph 3 –

A holder of a right to undertake commercial fishing of pelagic fish (pelagic bait included) shall pay the following levy per ton whole mass fish caught:

R 58.00 for directed pilchard (by-catch and industrial purposes inclusive) and

R17.00 for anchovy as well as for all other fish caught for industrial purposes;

3. For the purposes of paragraph 2, the mass of pilchard, anchovy, redeye (round herring) and horse mackerel shall be determined at a fish processing establishment in the presence of a fishery control officer (subject to paragraph 16).

4. A holder of a right to undertake commercial fishing of west coast rock lobster shall pay a levy of R 4,679.00 per ton whole mass of west coast rock lobster received/caught (subject to paragraph 16).
5. A holder of a right to undertake commercial fishing of south coast rock lobster shall pay a levy of R 3,906.00 per ton whole mass or a levy of R 8,682.00 per ton tail mass south coast rock lobster caught.
6. Subject to paragraph 16, a person who is the holder of a right to undertake commercial fishing by means of bottom trawl or midwater trawl nets shall pay the following levy per ton whole mass caught:

Hake caught in the offshore trawl and midwater trawl fisheries: R 350.00, hake caught in the inshore trawl fishery: R 350.00, sole: R 345.00, kingklip: R 349.00, horse mackerel: R 19.00, squid: R 427.00, east coast crustaceans: R 169.00, monkfish: R 230.00, ribbonfish: R 22.00 and snoek: R 27.00.

7. A holder of a right to undertake commercial fishing of abalone shall pay a levy of R 31,245.00 per ton whole mass of abalone caught or received.
8. Subject to paragraph 16, a holder of a right to undertake commercial fishing of traditional linefish shall pay the following levies (fixed payment per category) on whole mass of fish caught:

Two or less than two tonnes	R 161.00
Five tonnes and less, but more than two tonnes	R 565.00

9. (a) A holder of a right to undertake commercial fishing of tuna (pole and line method) shall pay a levy of R142.00 per ton whole mass of tuna caught and shall pay

R111.00 per ton whole mass of linefish by-catch caught.

- (b) The levies payable by holders of rights to undertake commercial fishing of tuna or swordfish by means of a longline per ton of fish landed are as follows:

10. A holder of a right to undertake commercial fishing of patagonian toothfish by means of a longline or pot shall pay a levy of R 375.00 per ton whole mass of patagonian toothfish caught (subject to paragraph 16).
11. A holder of a right to undertake commercial fishing of shark by means of a longline shall pay a levy of R 147.00 per ton whole mass of shark caught (subject to paragraph 16).
12. A holder of a right to undertake commercial fishing of hake by means of a longline shall pay a levy of R 350.00 per ton whole mass of hake caught, as well as a levy of R 349.00 per ton whole mass of kingklip caught (subject to paragraph 16).
13. A holder of a right to undertake commercial fishing of hake by means of a handline shall pay a levy of R 169.00 per ton whole mass of hake caught (subject to paragraph 16).
14. The holder of a right to undertake commercial fishing of squid shall pay a levy of R 427.00 per ton whole mass of squid caught.
15. A holder of a right to undertake commercial harvesting of seaweed shall pay a levy of R 118.00 per dry ton of kelp (*Laminaria pallida* [including *Laminaria schinzii*] and

Ecklonia maxima) and R 259.00 per dry ton of all other seaweed species as described in paragraph 1, gathered.

16. (a) For the purposes of paragraphs 3, 4, 6, 8,11,12 and 13 the whole mass of fish shall be determined by multiplying the mass of the fish caught or parts thereof (see column 1 below) with the appropriate conversion factor (see below). A factor of 1,00 shall be applied to any fish that are landed whole (unprocessed).

(b) Where a product is not listed in the above table, a conversion factor from an appropriate equivalent product shall be applied.

17. The levies payable in respect of fish caught during any one month shall be paid before the end of the following month, except in the case of traditional linefish (paragraph 8) where the levies will be paid before 31 December of the relevant year (based on the permit holders own catch returns). If necessary, in the case of traditional linefish, adjustments in respect of the levies payable will be made in the following year, and permit holders will be allowed to pay the adjusted levies on or before 31 January of the following year.
18. All payments of levies shall be accompanied by a form, certified by the holder of the right to undertake commercial fishing, that indicates the whole mass of fish caught or received during the month (or months in the instance of linefishing) concerned. This form is obtainable from: Customer Services, Marine and Coastal Management, Ground Floor, Foretrust Building, Martin Hammerschlag Road, Foreshore, Cape Town, 8001 / Private Bag X2, Roggebaai, 8012 / E-mail: revenue@deat.gov.za / Facsimile: 086 613 6256.
19. Interest and penalties will be imposed on any outstanding amount and late submission of levy declaration forms. Interest will be charged at the rate determined by National Treasury from time to time on any outstanding amount (except in the case of linefish, where it will be calculated from the first day of the year following the year in which the fish is landed). A penalty of 10% of the levies payable will be imposed on late submissions of levy declarations.
20. Levies, penalties and interest payable in terms of this Schedule shall be paid to: The Marine living Resource Fund, Ground Floor, Foretrust Building, Martin Hammerschlag Road, Foreshore, Cape Town, 8001 / Private Bag X2, Roggebaai, 8012 / Electronic Funds Transfer or direct deposit (proof of payment to be forwarded to revenue@deat.gov.za or 086 613 6256.

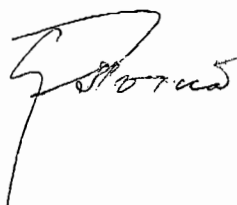

SCHEDULE

Definitions

1. In this Notice any word or expression to which a meaning has been assigned in the Act bears that meaning, unless the context otherwise indicates —

"the Act" means the Marine Living Resources Act, 1998 (Act No. 18 of 1998);

"active lay-up" means a vessel that is moored for a period that is longer than the norm for purposes of being repaired, altered, modified in part or whole or for some other acceptable on-going purpose, but where such vessel does not pose a threat or danger to other vessels in the harbour or to other harbour-users;

"alongside" means in relation to section 2 item A double and multiple banked vessels directly or indirectly secured to the structures mentioned;

"commercial activity or commercial use" means an activity or use with the purpose of securing financial return;

"fishing vessel" means a vessel engaged in sea fishing for financial gain or reward;

"hawker" means any person who does not use a fixed or semi-fixed structure and does not lease a temporary site to trade from;

"leisure or recreational vessel" mean a vessel that is used for an activity other than a commercial activity or any use other than commercial use;

"Mediterranean mooring" means the configuration of mooring a vessel so that its bow or stern is fastened to a quay, jetty, sea-wall, or breakwater, whilst its stern or bow (as applicable) is fastened to an anchor or block on the harbour floor, via a mooring line;

"normal working hours" means Mondays to Fridays (excluding public holidays): (08h00 to 16h00);

"passenger" means any person carried in a vessel except a person employed or engaged in any capacity on board the vessel on the business of the vessel and a child under one year of age;

"per week or part thereof", means the period extending from Monday to Sunday;

"per year"- or "per month or part thereof", means the periods extending from 01 January to 31 December of a calendar year or from the first to the last day of a month;

"register tons and register tonnage" has the meaning ascribed to it in section 1 of the Merchant Shipping Act, 1951 (Act No. 57 of 1951);

"Safety Certificate" means a certificate issued under section 194(1)(a) or (b)(ii) of the Merchant Shipping Act, 1951 (Act No. 57 of 1951);

"swing mooring" means a mooring configuration where the vessel is moored by one mooring line attached at one end to the bow and the other end to an anchor or block on the harbour floor;

"trader" means a person who uses a fixed or semi-fixed structure and leases a temporary site to trade from;

"trot mooring" shall mean a configuration where a vessel is moored by means of fastening two mooring lines, one from the bow and the other from the stern, each fastened at their other ends to their own anchor or block on the harbour floor; and

"unseaworthy vessel" means a vessel that is not in a fit state as to the condition of its hull, equipment or machinery, the stowage of her cargo or ballast and fuel, or the number or qualifications of her master or crew, her provisions and in all other relevant respects, to encounter the ordinary perils of the purpose to which the vessel is engaged or about to be placed or does not have a valid Safety Certificate.

- B. Vessels which are unseaworthy other than those in active lay-up (monthly tariff only) 5 x tariff 2.A
- C. Harbour lighting and navigation light fees for any vessel utilizing a proclaimed harbour for more than 30 days: R121, 00 per year

3. The slipping of vessels at main and side slip-ways (all harbours):

- For each 24-hour period or part thereof, including Saturdays, Sundays and public holidays on main and side slipways
- A. For each registered vessel of a gross register tonnage of less than 25 tons for the first 72 hours on the main or side slip: Once off basic fee of R121,00 plus R14,00 per full meter of total vessel length
- B. For each registered vessel of a gross register tonnage of more than 25 tons for the first 72 hours on the main or side slip: Once off basic fee of R452,00 plus R1,10 per ton (GRT x 2,83)
- C. For each registered vessel of a gross register tonnage of less than 25 tons on the side-slip, after the

first 72 hours and up to a maximum of 90

days and thereafter tariff 2.A:

60% of tariff 3.A

- D. For each registered vessel of a gross register tonnage of 25 tons or more on the side-slip, after the

first 72 hours and up to a maximum of 90

days and thereafter tariff 2.B:

60% of tariff 3.B

- E. Slipping or un-slipping of any vessel outside normal working hours, Saturdays, Sundays or

Public holidays an additional fee shall be payable: R241,00 per vessel

4. The tariffs as set out in 3, shall include the slipping and un-slipping of vessels during normal working hours and shall, for all fishing harbours, be:

(a) measured between the extreme points the nearest full meter (only where the tariff is length-based) and calculated from the time the slipway takes the vessel until the time the vessel leaves the slipway, and

(b) payable for each continuous period of 24 hours or part thereof, including Saturdays, Sundays and public holidays, during which the slipway is occupied, excepting that the booking fee is payable in advance in order to secure a position on the slip.

5. Hauling out of vessels at Arniston and Stilbaai:

A. During normal working hours: R14,00 per vessel

B. Outside normal working hours: R28,00 per vessel

6. Departmental cranes:**A. Ordinary cranes:**

1. Per hour or part thereof during normal working hours: R108,00
2. Per hour or part thereof, outside normal working hours: R176,00

7. Electrical power, availability and consumption, for each 8 hours or part thereof:
